They do not take the place of the individual retirement counseling with one of NJEA's pension consultants. For those, you need to make an appointment through the UniServ office.

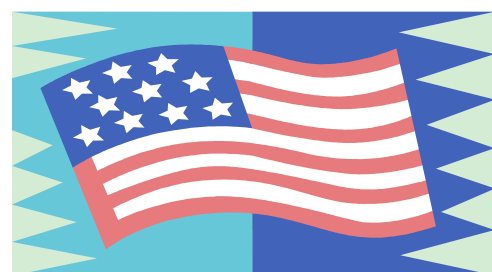
